Internship Information	<ul> <li>This is an unpaid internship</li> <li>We cannot provide housing for this internship</li> <li>SFWC requires interns to show proof of COVID-19 vaccination to participate in our programs. Proof must be submitted during the onboarding process via email or in-person to the Director of Outreach prior to the scheduled internship/externship dates. Those who are unable to get vaccinated must provide medical exemption, or a religious waiver.</li> <li>This Wildlife Rehabilitation Internship allows interns to assist rehabilitators in the daily care of animals. Interns will gain experience in species identification and natural history, proper husbandry techniques, animal handling, proper feeding of mammals, reptiles and birds, medication administration and lab work.</li> </ul>	
Position Grade	<b>3</b> ; background check includes Criminal Background, Social Security Number Verification and Sex Offender Registry	
Focus of the Internship	Introduce intern to the care of sick, injured, and adult or juvenile wildlife and certain non-natives. Job duties include feeding animals, setting up and cleaning enclosures, preparing diets, administering daily medications, and general cleaning.	
Learning Opportunities	<ul> <li>Learn the care and husbandry challenges of the animals in our care.</li> <li>Gain hands-on wildlife experience including proper handling procedures, feeding techniques, husbandry, species-specific diets, and administration of medications.</li> <li>Learn what is involved in rehabilitating an animal in preparation for release such as flight conditioning, enrichment, waterproofing, etc.</li> <li>Exposure to the operations of a wildlife center.</li> <li>Knowledge of humane coexistence with wildlife.</li> <li>Knowledge of rescues techniques when available.</li> </ul>	
Orientation/Training	Onboarding is completed by the Outreach Department but Interns will be trained by the Rehabilitation Department on the particular aspects of their role by meeting one-on-one with staff members and being cleared to work in the different areas.	
Intern Responsibilities	<ul> <li>Clean and set up enclosures/habitats.</li> <li>Prepare diets and supplemental feeding formula.</li> <li>Hand feed animals using appropriate techniques.</li> <li>Document all care and observations.</li> <li>Handle patients for weighing, treatments, and transfers.</li> <li>Assist with routine care and physical exams.</li> </ul>
